Applications accepted according to the following schedule:

***Starting Jan 1, 2024:** NID property owners who have **not** received any prior exterior grants.

***Starting May 1, 2024:** NID property owners who have received **only** an Exterior Lighting Grant.

***Starting Sept 1, 2024:** **Any** NID property owners – regardless of prior grant receipt.

Terms and conditions:

- **Property address must be located in the Havenwoods Neighborhood Improvement District #9 (see map).**
- **Eligible improvements include** doors, windows, siding, roofs, painting, trim and aesthetic improvements visible from street, landscaping, porch repair, railing and fence repair/installation, cement/asphalt walkway or driveway repair/installation. Homeowners are responsible for understanding and obtaining any necessary permits.
- **BEFORE work may begin, an application must be approved** by Havenwoods NID#9 Security Committee. Only work completed or purchases made after application is approved by the NID will be accepted. NIDC will confirm that the requested work is eligible and that funding is available for the project. Grants are only available while funding lasts.
- **Cash payments to contractors are NOT acceptable.**
- Homeowners must submit original receipts and invoices, including any canceled checks of amounts paid out, (copy of permit for fence installation), and final report form prior to receiving any reimbursement. Cash payments to stores that are reflected on a store receipt are permissible. Applicants must provide a canceled check or verification of credit card payment or money order for contractor payment.
- Maximum grant funds per property owner are \$3,000. Homeowners must provide a minimum contribution of 25% of overall project cost.
- Homeowners who have not received other NID grants (Door & Porch/Fence/Walkway) will have priority for funds – see schedule on the first page.
- Before and after photos of the project required to track progress and for use in promotional and media purposes.
- Any changes to project scope or timeline must be submitted as a request to NID#9, and should only take place with NID#9 approval.
- Projects must be completed within 60 days of the approval date. Incomplete projects at the 60 day mark and without the above timeline change request may be moved to the end of project waiting list.

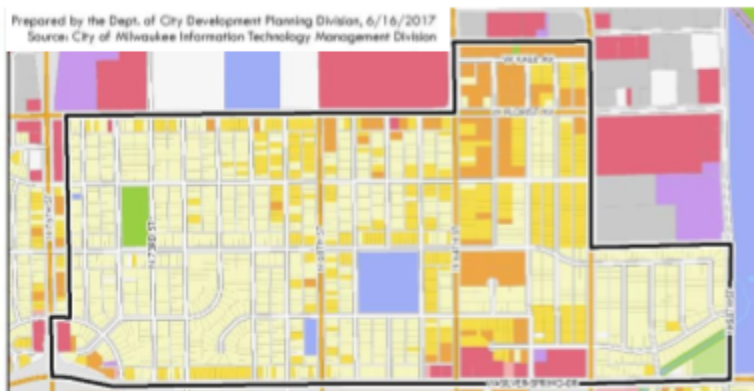
